The first regular meeting of the Dixon County Board of Supervisors for the year 2017 convened at 9:00 A.M. for reorganization in the Jury Room in the Dixon County Courthouse in Ponca, Nebraska on January 10, 2017. The meeting was opened with the Pledge of Allegiance. Notice was given to the public of the location of the posted Open Meetings Law.
